



SPECIAL POPULATIONS SCHOLARSHIP FUND

The Special Populations Scholarship fund was established to assist students in need with their unmet education expenses. Scholarship awards will be made to students meeting the eligibility criteria as determined and approved by the Foundation Scholarship Committee. Students may use appropriated funds for tuition, fees, books and required classroom supplies.

Eligibility Criteria & Application Process

Criteria:

- Meet one or more of the Special Populations' categories as defined by the Carl Perkins Act. Categories include:
 - Single parent students who have the primary or joint custody of a dependent child
 - Single pregnant women
 - Displaced homemakers who have worked without pay to care for a home and/or family and for that reason have diminished marketable skills; have been dependent on the income of another family member but are no longer supported by that income
 - Economically disadvantaged students who are Pell Grant recipients or who are receiving federal assistance such as Food Stamps, TANF and/or Medicaid
 - Students enrolled in nontraditional programs of study that lead to occupations or fields that have 25% or less of their gender employed within the occupation
 - Students with limited English proficiency
 - Students with disabilities
- Applicants must be in good academic standing in accordance with college guidelines.
- Applicants must have a completed FAFSA on file with the Lanier Technical College financial aid office for the year scholarship funding is being requested.
- Applicants must complete a Lanier Technical College Foundation Scholarship application.

Selection & Award Process

Selection Process:

- The Lanier Technical College Foundation Scholarship Committee will make the determination of awards.
- Award notification will be emailed to students at their Lanier Tech student email account from a member of the Foundation office.

Award Information:

Scholarship awards are based on the number of credit hours a student is enrolled for the semester.
